## Section 2: HAZARDS IDENTIFICATION

**Classification:** This mixture does not need to be classified according to regulation (EC) No. 1272/2008.

**General information:** Aqueous solution of recombinant *Betula verrucosa* (*Betula pendula*) Bet v 4.0101.
