Section 2: HAZARDS IDENTIFICATION

Classification: This mixture does not need to be classified according to regulation (EC) No. 1272/2008.

Section 3: COMPOSITION/INFORMATION ON INGREDIENTS

General information: Aqueous solution of recombinant *Phleum pratense* Phl p 12.0101.
